## Remembering BRADFIELD

ifty years ago, a lot of the summer social life in Lincoln revolved around local hangouts. For the young people in this neighborhood, the hangout was Bradfield Drug.

Although its original location on the northwest corner of 28th and South is just outside of our official CCNA boundaries, Bradfield Drug is still a part of the history of our neighborhood. According to Lincolnite Jerry book, The Good Old Days, Bradfield

Drug was the "social mecca to anyone growing up in southeast Lincoln in the '30s and '40s. Teenagers and younger gathered every evening both inside and outside Bradfield Drug to plot their evening's forays."

Inside the drug store, older teenagers worked as fountain boys at the soda counter along the west wall. Outside, young people gathered on the sidewalk to talk and watch people go by. Despite the crowds, Mapes didn't recall much mischief. "It was just a social gathering place for those of us on foot and bikes.'

Chick Thorne, another longtime Lincoln resident, had slightly different recollections. He recounted several minor escapades in front of Bradfield Drug aimed at annoying the patrolman who would stop to check on the activities. "One Halloween, we snuck around the patrol car and bent his license plate into a U-shape. Another night we lobbed a water sack into the patrol car."

Thorne also remembered when they faked an accident by speeding around the corner and throwing a trash can off the back of the car. The young men involved hoped the sound of crashing metal would bring the patrolman running. "In those days, there was a different relationship between police officers and young people. Mischief was handled differently. No one worried if anyone was carrying weapons," said Thorne.

According to County Assessor records, the brick building

comprised of several storefronts was built in 1928. However, a 1924 City Guide of Lincoln already shows three businesses operating on the site: a laundry, a grocers and a drug store called Harlan Drug. In the 1931 City Guide, the drug store listed a new owner and a new name: Bradfield Pharmacy. Lincolnites simply called the establishment "Bradfield Drug" and the name remained through subsequent owners and "official" name changes. The drug store

operated at the 28th and South location until 1956 when its owners relocated it to Rathbone Village where it remained in business for many more years. At that time, the current tenant, Pechous Upholstery, moved into the site.

says longtime Lincolnites occasionally

stop by the shop just to get a glimpse of the old hangout. "It looks fairly different when they first walk in. We had to put a drop ceiling in the front area because the exterior windows were falling in."

However, in the back rooms of the upholstery shop, the original tin ceiling and crown molding are still in place...as is the green color of the old Bradfield Drug walls. Those architectural remnants, and the fond memories of the people who flocked there decades ago, are all that remain from the days when Bradfield Drug was the hot spot of the neighborhood.





This as well as four other 'Bike' sculptures in the Country Club Neighborhood (71 sculptures throughout Lincoln) can be seen this summer, but don't wait too long, come this October the installations will be removed and auctioned off (yes the cement is temporary as well).

### Pocras Park

Pocras Park - a neighborhood stop for children and families, older residents on walks, kids with Frisbees - needs a few friends. The park is nestled in the wedge between Bradfield Dr., Sewell St., and Jefferson Ave. Its playground equipment is outdated and no longer meets safety codes. With limited trees to shade the play space, the aging metal equipment is often too hot for children to play on.

According to Lincoln Parks and Recreation, Pocras Park began not as a park at all, but rather a median bed. The county used the median for storage and erected a shed. In the 1950s, the shed was replaced with a backstop and the park became a draw for neighborhood pick up games. In the mid-1970s, Lincoln Parks and Recreation took over the site, but it wasn't until 1985 that they installed playground equipment with funding from the Pocras family. The Pocrases donated funds to create a playground, path, backstop, and landscaping for the park in memory of Richard E. Pocras, who grew up in the area.

Today, Pocras Park is heavily used by area residents, both young and old. Area daycare centers and social service programs bring children to use the swings, merry-go-round and slides. To keep the park a wonderful place for all of these folks, it is critical to assure that it is safe, accessible, and attractive. To address Pocras Park's needs, former CCNA President, Linda Wibbels, called for a committee of interested neighbors to take on the project. Several area residents responded and have already worked with Lincoln Parks and Recreation on a draft Master Plan. This draft will go before the CCNA for approval pending final changes and cost estimates. If approved, fundraising for the playground and landscaping will begin.

#### **Warm Weather and Road Works**

President's Message

Now that spring has finally decided to stay, along with it came the construction season. As most of you have already discovered while driving to work or shopping, as of May 12th, the South Street Improvement Project is underway. And just

in case you have not found the alternate route into the Rathbone Village shops and businesses, thanks to some last minute negotiating via City Councilman Jonathan Cook, limited access remains in place from the east on South Street. From the west try access from any number of points feeding Winthrop Road from the south but be extra watchful for pedestrians, both kids and adults as well as our pets. Remember residential streets are limited to 25 miles per hour versus South Street at 35 mph. The South Street Shops from 27th to Bradfield have alternate routes as well but again it requires caution driving on the residential streets leading from north to these businesses. Although this project, which involves installation of a new water main, new curbs, and street resurfacing from 27th east to 38th Street, was initially planned to require 90 days to complete, with any ensuing poor weather it may require a few days longer. A call to the Public Works Department (441-7548) will keep you updated on any possible change in the construction schedule. If all goes well we will have South Street back in action the last half of August.

As reported in the last Chronicle another street improvement project, which appears to be heading our way, perhaps this fall or spring of next year, is a new roundabout for the intersection at 40th & Sheridan Boulevard. Several CCNA members and I have had the opportunity to participate with our neighbors to the east in the development of plans for this roundabout design which will be little surprise to anyone since it is essentially a repeat of the 33rd Roundabout with minor changes to the pedestrian crossing locations. Although a number of area residents attended the first public meeting April 10th to view the proposed design, a second and final public meeting is planned Tuesday, June 3rd, at a location to be determined. Please call the Public Works Department for the time and location for this final presentation.

My last topic falls into the 'little known laws you should be aware of category. As you also know from our last Chronicle, it is now unlawful to leave your pet's waste on public property. My thanks to those who have increased your attention to this small but important "duty"...the neighborhood and the entire City thanks you.
Also many of us now have 'legal yards' whereas prior to the recent City Council passage of the changes to applicable ordinances, those of us who had more than grass or trees in our yards between the curb and sidewalk, were on the wrong side of the law or at least 'public offenders'. For our neighbors who have had beautifully trimmed hedges or other features between your sidewalk and curb (some dating to the 1920's) you may now rest easier these days knowing you are a lawful gardener with more landscape options available.

(Please note this change in City ordinance only applies to the area between your lot line and the curb and not the area located on the landscaped medians in the center of the street on many of the neighborhoods avenues and boulevards. These medians have a specific landscape plan which was approved by the City Parks Department with the CCNA in 1998, the drawings of which are being developed for distribution by the end of this year.)

## **Neighborhood Respect**

Have vou ever considered how remarkable it is that what we call today the Country Club Neighborhood which dates back over 80 years in some areas, has in my opinion never had what I call a 'slump or period of decline' from which we had to 'come back?' This is a

claim many other neighborhood areas of similar vintage in this city cannot make. Of the many reasons for this longevity I believe one must be that our neighbors both today and in the past, have maintained a remarkable

level of respect for one anothhave we taken pride in our we live. Recent cases in point, Lighting Initiative or luminaridays or landscape maintenance in the public street right-of-way.

During my tenure as CCNA president, I have had many neighbors make comments to me about their concerns involving what I collectively call neighborhood respect. A few of these respect issues I would like to share with you. Since garbage collecting has evolved from the days of my youth, when all garbage was carried by your route collector from the back of each home out to the truck, into our modern method where each resident is responsible for delivering their two-wheeled black plastic barrel or barrels to the



curb for early morning pick-up, I have often heard the following, "Why must people leave their empty trash barrels at the curb for so long before putting them back out of sight?" To respond to this issue I ask on behalf of those

who have talked to me and on behalf of the entire neighborhood, that within the day of garbage pick-up we all return our trash barrels from the curb to the out-of-sight location at the back of our properties. If your neighbor leaves for out-of-town activity that day, maybe help them out periodically by moving their empty barrel to the back of their property.

Also, as we go about our warm-weather business outside, here are some facts I recently learned from a neighbor about yard signs. It is unlawful for a resident to place their 'Garage Sale',




